Grading Permit Application and Requirements

READ CAREFULLY any omissions will delay processing of your application. A full copy of the Grading Ordinance can be viewed at the Township Building.

The following information, where applicable, must be submitted with the application:

Application Checklist: All the following must be complete and appropriate documentation attached before the application will be accepted.

- Approved E & S Plan along with NPDES Permit (1 or more acres) N/A
- E & S Plan for Township review (less than 1 acre more than 5,000 sq. ft.) N/A
- The application has been completely filled out.
- Min. three (3) copies of the Plans and specifications, prepared, signed and sealed by a professional engineer, surveyor, or landscape architect and include the following:

- Plans shall be at the scale of 1" = 20', or as permitted by Township Engineer.
- A description of the site proposed for grading.
- Accurate Location by lot, block, tract, street address, a location map, or other similar information.
- A contour map showing the existing contours and the proposed contours not less than two (2>) feet or as permitted by the Township Engineer.
- Cross sections of the proposed cut or fill, which show the method of benching both, cut and/or fill.
- The location of the grading boundaries, lot lines, neighboring streets or ways, buildings, surface and subsurface utilities, and waterways.
- A description of the type and classification of the soil from the Soil Survey or better.
- Details and location of any storm water management facilities or drainage control structures, pipes, walls, and cribbing.
- Seeding and/or planting locations and schedules, debris, basins, diversion channels.
- Nature of the fill material and such other information as the Township Engineer may need to ensure conformity to the Township ordinance.
- Quantity of cut and/or fill in cubic yards.
