**RESOLUTION OF THE NORTH FRANKLIN TOWNSHIP BOARD OF SUPERVISORS, WASHINGTON COUNTY, PENNSYLVANIA, CONFIRMING ACCEPTANCE OF THE INTER-GOVERNMENTAL COOPERATION AGREEMENT WITH SOUTH FRANKLIN TOWNSHIP, A NEIGHBORING TOWNSHIP, REGARDING THE MAINTENANCE OF MOORE ROAD AND VANKIRK ROAD.**

**WHEREAS**, the Board of Supervisors of North Franklin Township pursuant to its powers set forth in the Municipalities Planning Code (See §1010 *et seq.*), and Act 80 of 2019, amending 53 Pa.C.S. § 2305 *et seq.* of the Pennsylvania Consolidated Statutes desires to enter into an Intergovernmental Cooperation Agreement with South Franklin Township; and

**WHEREAS**, North Franklin Township, and South Franklin Township have been exchanging maintenance duties on Vankirk Road and Moore Road for many years and both have expressed a desire to enter into a formal, written agreement; and

**WHEREAS**, Erin Dinch, in her position as Director of Planning and Development has carried out discussions with representatives of South Franklin Township to specify the terms of such agreement; and

**WHEREAS**, a Cooperative Maintenance Agreement setting forth the maintenance duties of each township in greater detail has been compiled and attached hereto as Exhibit A;

**NOW THEREFORE BE IT RESOLVED** that the North Franklin Township Board of Supervisors at a Public Meeting held on March 10, 2020, voted to accept and approve the Cooperative Maintenance Agreement with South Franklin Township.



**between**


### **North Franklin Township and South Franklin Township**

Pertaining to Moore Road and Vankirk Road, both Townships agree to the following:

1. North Franklin Township will perform all winter maintenance duties on Vankirk Road and South Franklin Township will perform all winter maintenance duties on Moore Road as an even exchange.
2. Whenever South Franklin Township performs tar & chipping of Moore Road, North Franklin Township will reimburse South Franklin Township for the expense of tar & chipping the 0.1 mile of Moore Road that is in North Franklin Township.
3. South Franklin Township will be responsible for tar & chipping the end of Vankirk Road between the bridge and Route 18. North Franklin Township will be responsible for tar & chipping Vankirk Road between Cleveland Road and the bridge.
4. North Franklin Township agrees to maintain potholes and other minor maintenance on Vankirk Road and South Franklin Township agrees to maintain potholes and other minor maintenance on Moore Road as an even exchange.
5. South Franklin Township will assume responsibility for the bridge on Vankirk Road.


