RESOLUTION OF THE NORTH FRANKLIN TOWNSHIP BOARD OF SUPERVISORS APPROVING THE PETITION OF DAYNA SAGE AND VON SAGE TO VACATE AND ABANDON ANY PUBLIC INTEREST THE TOWNSHIP HAS IN 'HAWTHORNE STREET' AND THE UNNAMED 20-FOOT ALLEY SET FORTH IN THE THORNYCROFT LAND COMPANY SECOND ADDITION OF RECORD AT PLAN BOOK 5, PAGES 110-111 INSOFAR AS SAID AREAS IN QUESTION ARE NOT LOCATED IN NORTH FRANKLIN TOWNSHIP AND THE TOWNSHIP HAS TAKEN NO ACTION TO OPEN AND/OR MAINTAIN SAID STREET/ALLEYWAY.

WHEREAS, by petition received on September 16, 2021, Dayna Sage and Von Sage petitioned the Township to vacate and abandon its interest in Hawthorne Street and the 20 foot unnamed alley appearing of record in the Thornycroft Land Company Second Addition, appearing of record in the Washington County Recorder of Deeds Office at Plan Book 5, Pages 110-111 (Petition attached hereto as Exhibit A); and

WHEREAS, upon reviewing the Petition, the Township has determined that Hawthorne Street and the unnamed 20-foot alleyway are not located in North Franklin Township; and

WHEREAS, the Township has also determined the areas in question have never been accepted, opened and/or maintained by the Township within the time period prescribed by Title 36 of Pa. Statutes, Section 1961.

RESOLVED that the North Franklin Township Board of Supervisors at a Public Meeting held on October 12, 2021, voted to approve the Petition and confirm the Township has never opened and/or maintained Hawthorne Street or the Unnamed Alleyway.

BE IT FURTHER RESOLVED, the Township hereby vacates, abandons and relinquishes any public interest in Hawthorne Street or the Unnamed 20 foot alleyway.

FINALLY RESOLVED, the Secretary of North Franklin Township is further directed to execute a certificate attesting to the adoption of this resolution and to maintain a copy of the resolution within the North Franklin Township Municipal Office and posted on the Township website when possible.
