

**NORTH FRANKLIN TOWNSHIP
RESOLUTION NO. 13 of 2023**

**A RESOLUTION OF NORTH FRANKLIN TOWNSHIP,
COUNTY OF WASHINGTON, COMMONWEALTH OF PENNSYLVANIA,
APPROVING THE TRANSFER OF RESTAURANT LIQUOR LICENSE R-6322, LID-
90146 INTO NORTH FRANKLIN TOWNSHIP FROM INDEPENDENCE
TOWNSHIP**

WHEREAS, Act 141 of 2000 (“the Act”), which amends the Commonwealth’s Liquor Code, authorizes the Pennsylvania Liquor Control Board to approve, in certain instances, the transfer of Restaurant Liquor Licenses across municipal boundaries within the same county regardless of the quota limitations provided for in Section 461 of the Liquor Code, if sales of liquor and malt or brewed beverages are legal in the municipality receiving the license; and

WHEREAS, the receiving municipality issues a resolution approving the transfer of the license outside the municipality to inside the municipality; and

WHEREAS, amendments to the Liquor Code stipulate that prior to adoption of a resolution by the receiving municipality, at least one hearing is held for the purpose of permitting interested parties to state their concerns regarding the transfer of a Restaurant Liquor License into the municipality; and

WHEREAS, an application for transfer filed under the Act must contain a copy of the resolution adopted by the municipality approving the transfer of a restaurant liquor license into the receiving municipality.

NOW THEREFORE, BE IT RESOLVED, That Interstate Golf and Activity Center, LLC has requested the approval of North Franklin Township for the proposed transfer of Pennsylvania Restaurant Liquor License R-6322, LID-90146, currently owned by Kirchs Tavern, LLC, to its facilities within the North Franklin Township, 2200 Old National Pike, Washington, PA 15301, with the understanding that said transfer must be approved at a later date by the Pennsylvania Liquor Control Board; and

BE IT FURTHER RESOLVED, that North Franklin Township, following a public hearing held pursuant to public notice, finds that the transfer of a Restaurant Liquor License into the Township by Interstate Golf and Activity Center, LLC will not adversely affect the welfare, health, peace and morals of the Township or its residents.

BE IT FURTHER RESOLVED, that the Township of North Franklin Board of Supervisors approves, by adoption of this Resolution, the proposed inter-municipal liquor license transfer of Interstate Golf and Activity Center, LLC from 42 Campbell Street, PO Box 313, Avella, PA 15312 to 2200 Old National Pike, Washington, PA 15301.
