### **FIRE CHIEF'S REPORT**

Fire Chief Dave Bane reported that for January 2025 the Fire Department had 21 calls including one (1) cooking fire, seven (7) medical assists, three (3) motor vehicle accidents, one (1) carbon monoxide, one (1) vegetation fire, one (1) water problem, one (1) non-building structure fire, one (1) fire of other type, one (1) public service, one (1) special incident and three (3) unintentional alarms. The average response was 9 minutes and 5 seconds, and they averaged 5.4 people per call. Year to date 21 calls.

<u>SOLICITOR'S REPORT</u> – Mr. Sweat reported that the Redevelopment Authority was on course to demolish 63 Cleveland Road. He said Mr. Loar has been making threats but there is a court order on file. He recommended Police assistance on the day of the demolition. He also reported that a municipal lien has been filed against the mall property in regard to the Rural King Subdivision.
